### The Changeover

If you haven't heard it yet, the repeater now has a new ID. N6NFI. The changeover has been smooth so far. Though, I'm glad me to get it together.

#### Looking Back

The first entry in the Rich's repeater log book is 1/24/83. Rich and Dave Honkala where at the site measuring the back-up battery voltages. NARCC. Much time, many phone calls and letters to NARCC and the FCC, along with copious amounts of patience, resulted in the 145.23 repeater frequency pair remaining with our machine.

Programming the controller and keeping the repeater up and running has required a constant effort. Besides hardware work, learning to "control" the controller took a lot of study and (The repeater thinks the date is 22 February, creativity. 1972...Too bad, Y2K!) The hardware wasn't designed to interface together from the beginning and some roundabout methods were used. All of the programming has been done manually... one button at a time.

### The Prez Sez...



#### West Valley ARA Announces Web-Based Exam Site

The software generates a random exam on a web form the same way that the Volunteer Examiner Coordinator (VEC) organizations would. These are from the same published question pool as the actual exams so these are real and effective practice. in addition, WVARA's practice exams can be taken a section at a time as one studies through other materials.

#### N6TV Resigns as CAC Rep. for the Pacific Division; N6IG Takes the Helm

Bob Wilson, N6TV (a.k.a. TV-Bob) has done an outstanding job of serving the Pacific Division as representative to the ARRL Contest Advisory Committee for the past six years. Unfortunately, business commitments made it impossible for Bob to continue in the CAC post, so he regretfully resigned effective Feb. 1. Fortunately, waiting in the rings was (drum roll) Jim Pratt, N6IG, who has agreed to take on the job.

First licensed in 1973, Jim joined Northern California Contest Club in 1975 and has been active ever since. He is the holder of Pacific Division single operator records in ARRL DX CW and ARRL November Sweepstakes, CW and SSB. He also holds the Zone 3 CQWW CW single operator record. He is co-leader of a team that holds June and September VHF QSO Party multi-op Pacific Division records. Jim is a frequent operator at N6RO multi-operator efforts, and is "chief operator" of the W6GO station. He has operated phone and CW at P40V and PJ1B/PJ4B/PJ9B in CQWW contests.

Jim was a competitor in WRTC-1996 with K4UEE, taking a fifth place finish out of 52 entries. He was recently selected as team leader for WRTC-2000 by the NCCC.

#### "Bip" Bachman, W6BIP, Silent Key

The passing of Wilbur "Bip" Bachman, W6BIP, on Feb. 2 saddened Hams throughout the DXing and contesting community. Bip was originally licensed in 1928. His interest in DX led to a lifelong interest in travel, and as a result he and wife Elsie met in person many of those DX hams he had first met over the air. As a final salute to Bip, members of the Northern California Contest Club all used the name "Bip" in their exchanges during the CW North American Sprint held Feb. 12.

#### ULS Forms Required Beginning Feb. 17

When the Universal Licensing System (ULS) was made available for the Amateur service, the FCC's Wireless Telegraph Bureau announced that Forms 610 and 610V would continue to be usable for six months. That grace period will expire in only a few days, at midnight, Feb. 16. The Bureau will dismiss without prejudice all applications received on or after February 17, 2000, if filed using Forms 610 and 610V. From that date on, all Amateur licensing (with the exception of club stations) must employ the new ULS Form 606. Prior to filing Form 606 it is necessary to register This web-based examination software was originally written for using Form 605. Either electronic or paper versions of these two forms may be used.

#### **Upgrading on April 15? CAUTION!**

Many hams throughout the Pacific Division, as well as elsewhere, are taking upgrade exams now with the intention of upgrading on April 15. Please note the above, regarding ULS. All applications following Feb. 17, including upgrades, will need to be filed using a ULS Taxpayer Identification Number (TIN). In order to make your upgrade go smoothly, be sure you register and obtain your TIN number well ahead of April 15! It's not necessary to have any license change in process in order to register, but registry will be necessary in order to upgrade on April 15! #### ARRL Board Endorses Certification Program

The ARRL Board of Directors has approved the development and implementation of an initiative to promote self-education by radio amateurs. The new ARRL Certification Program will aim to inspire amateurs to continue acquiring technical knowledge and operating expertise beyond that required to become licensed and give them a chance to test their own limits. Following up on the "2010 Vision" discussions at last July's Board meeting, ARRL Executive Vice President David Sumner, K1ZZ, presented the broad strokes of the Certification Program during the Board's January 21-22 meeting in Memphis.

At this point, the Certification Program only exists as a concept, with the details to be worked out, but plans call for having the program in place by later this year. The first step in putting the program in place will be to solicit the ideas of ARRL members, via a Web-based message board, on appropriate topics to be included in the initial rollout. "The idea is to make this program what members want it to be, and not something imposed from 'on high,'" Sumner said.

The new Certification Program will offer participants an opportunity to earn credentials at various levels of depth and difficulty in different courses of study--perhaps in such areas as ionospheric propagation, receiver design, and Morse code proficiency. Sumner said the ARRL should and will continue to encourage the development of Morse code proficiency beyond the basic HF licensing requirements. He observed that the standards for ARRL certification could be more stringent and more uniform than those used for FCC exams.

As envisioned, the program would be largely self-supporting, but startup costs would be funded from the Exceptional Merit Stipend established by the late Ethel Smith, K4LMB. The Certification Program will be dedicated to her memory. Smith--who helped found the Young Ladies Radio League and served as its first president--died in 1997, leaving the bulk of her estate to the ARRL.
