# A Note from the Treasurer

#### **HOSPITAL NET ON 523**

From the inception of the 523 repeater, it has been our policy to be an open repeater and support public service in the true spirit of amateur radio. We have welcomed new hams to the machine and have made the repeater available for bike-a-thons, walk-a-thons, coordination of community events such as the annual Palo Alto Snowman and Sleigh event, etc. Many years ago, we were asked to make the 523 repeater available in time of emergency (and for emergency drills) for use by the peninsula hospitals to supplement their normal communications system and to help them coordinate the medical needs of our area. This emergency use was the prime reason we installed a back-up battery system on the repeater that keeps the repeater on the air even when the AC power fails. During the 1989 Loma Prieta earthquake, a hospital net was established on 523.

Over the years the people in charge of emergency communications have changed, both in the ham world as well as in the various cities and counties. The current emergency coordinator was unaware of the above historical usage of our repeater and was looking for a machine that would provide the needed coverage. She was surprised to learn that the 523 repeater had been used in the past. After a few test transmissions from a mobile making the rounds to various hospitals, she has asked SPARK and SARS to sign a Memorandum of Understanding (MOU) that would put us on record as having agreed to use of the repeater for a hospital net in time of emergency and for two to three emergency drills a year.

I will be coordinating this effort and plan to bring the MOU to the February or March meeting for an official vote after coordinating the wording with the club officers, SARS, and Control Ops.

#### **PHONE LINE DOWN**

As any listener to 523 is aware, the 9 AM talk net has had a lot of jamming in recent weeks. In addition, the jammer has been dialing up 911 repeatedly and letting the phone hang, or worse. This has created a problem for the host of our phone line. To prevent losing the line, the patch has been temporarily disabled. Rolf, N6NFI, has located an electronic box that is intended to block certain outgoing calls, e.g. 900 numbers. We are in the process of looking into ordering the device. The cost is approximately \$82. A motion to make the purchase will be brought up at the February SPARK meeting. Once the device is installed and tested, we plan to re-enable the patch. This device will keep us from losing the phone line.

Unfortunately, this box will not prevent a jammer from dialing up one of the emergency agencies on the Emergency Autodial list and causing a problem there. The diligence of ALL club members is needed to minimize this problem. When you hear someone making an Unidentified patch, use the hang-up code to terminate the call. When I have not been sure whether the call is a jammer or for real, I terminate the call first. (Usually I've been monitoring, so I KNOW that the station did not previously ID) Then, I come on the

accessing the patch to identify. If the station identifies and is in therefore, compliance is very important. need of help, I facilitate the call by either dialing the correct If the response is another burst of touch tones, I continue to terminate the patch. I do NOT acknowledge the jammer.

If you hear someone misusing the patch, please jump in and help. If the jammer is continually thwarted, perhaps he'll become discouraged.

#### Ham RF Exposure Guidelines Effective Jan. 1, 1998:-

#### FCC Lists Items For Biennial Regulatory Review:-

Among 31 proposals by FCC staff for review released on Feb. 5, 1998, was this one involving the Amateur Radio Service:

"WTB Part 97: Streamline Amateur Radio Service. Seek comment on amending Parts 0, 1, and 97 of FCC Rules to privatize further the administration of the Amateur Radio Services and to simplify the licensing process."

Just what will come of these proposals is unclear, but ARRL is tracking the proposals closely.

#### **US To Participate in CEPT Guest License** Agreement:-

For many years efforts have been underway to secure US participation in the European CEPT agreement that permits licensed hams in European member countries to operate in other member countries without receiving prior, individual approval. Approval of the US request to participate came in late January at a meeting of the CEPT Radio Regulatory Working Group (WGRR), in Groningen, The Netherlands.

What this means, is that US amateurs also will not need to apply for reciprocal licenses in order to operate during short visits to most European countries. Similarly, most European hams visiting the US no longer will have to submit FCC Form 610A.

Under the arrangement, a US Technician license will be recognized as a CEPT Class 2 (VHF-only) license, with full privileges above 30 MHz. Holders of Tech Plus through Extra tickets will be given a CEPT Class 1 license, with full privileges on HF and VHF. Novice licensees would not be eligible for a CEPT equivalent license since most CEPT countries don't offer a license of this type.

The time schedule for final implementation of the agreement hasn't been announced. Watch QST, the ARRL Letter, and this Update for further developments.

#### Call for Applications for 1998 Scholarships:-

The Foundation for Amateur Radio, Inc., a non-profit organization with headquarters in Washington D.
