AUTOPATCH / AUTODIAL UPDATE

As frequent repeater users are aware, the phone interconnect with the 523 repeater has been disconnected for several months. This inconvenience to all was necessitated by crank calls that ended up on the host's emergency line. Trying not to reinvent the wheel, we searched for an existing solution to block such calls. We thought we had found the ideal "black box" to do the job, but the supplier was concerned about the legal implications of our use of their box. After many weeks of promising to ship, they decided not to sell us the box.

delivery of a neat, compact, unit with a lot of flexibility. When tested, the box's internal timing was too slow, so back it went for reprogramming. Finally (?) the week of April 19th, the box was returned to us. We expected it to work, and had hoped we could announce reconnection of the patch in this May Newsletter. Unfortunately, upon connecting the reprogrammed box, the dial tone did not come through. So, more calls to the company and the saga continues.

Definition of terms: Autopatch is the ability to dial any number at random within our calling area. Autodial is the ability to dial prestored numbers using a quick, few-digit number instead of dialing the number 1, the area code, and the seven digit number. The autodial is divided into two sections: the emergency autodial which contains the seven digit equivalent of the 911 numbers for fire, police, paramedics, etc. and the personal autodial which contains members' home phone numbers or whatever number they choose that they call frequently.

When the autopatch/autodial are up and running, paid up members will receive new access codes for the autopatch. Autodial slots will be reactivated ONLY for paid-up members.

At that time we will run the announcement telling people how to obtain the emergency autodial codes. That will communicate to club members that the patch is working. Of course, we will also

Amateur Radio Spectrum Protection Act Introduced in House of Representatives:-

On March 27, Representatives Michael Bilirakis (R-FL-9th) and Ron Klink (D-PA-4th) introduced HR 3572, the Amateur Radio Spectrum Protection Act of 1998.

The operational portion of the bill is Section 3 (see below), which, if passed, would require the FCC to provide "equivalent replacement spectrum" if the Commission reallocates any primary or secondary Amateur Radio frequencies.

The bill has been referred to the House Commerce Committee. While it is too early to offer any prognosis, the House only has about fifty days left actually in-session before the proposed October adjournment.

Our strategy must be very straightforward - a simple numbers game of gathering as many House cosponsors as we can.

Here is Section Three:

"SEC. 3. FEDERAL POLICY REGARDING REALLOCATION OF AMATEUR RADIO

SPECTRUM.

Section 303 of the Communications Act of 1934 is amended by adding at the end the following new subsection:

- (y) Notwithstanding subsection (c), after July 1, 1998--
- (1) make no reallocation of primary allocations of bands of frequencies of the amateur radio service;
- (2) not diminish the secondary allocations of bands of frequencies to the amateur radio service; and
- (3) make no additional allocations within such bands of frequencies that would substantially reduce the utility thereof to the amateur radio service; unless the Commission, at the same time, provides equivalent replacement spectrum to the amateur radio service."

Here is a draft sample letter to send to your Congressman to enlist him/her as a cosponsor:

The Hon. (congressman name) Longworth House Office Building Washington, DC 20515

Dear Representative (congressman name):

As one of the nation's more than 650,000 licensed radio amateurs, I urge you to sign on as a cosponsor to HR 3572, the Amateur Radio Spectrum Protection Act of 1998.

This bill, introduced by Representatives Bilirakis and Klink on March 27, is a non-partisan, non-controversial measure designed to afford a measure of protection to Amateur Radio frequencies used by radio amateurs in (state name) and elsewhere to provide emergency communication, technical experimentation and recreation.

The bill would require the Federal Communications Commission to provide "equivalent replacement spectrum" in the event it becomes necessary to reallocate radio frequencies currently allocated to the Amateur Service.

This is a matter of fairness, and is in the national interest.

The bill would help ensure Amateur Radio's continued public service role to the people of the State of (state name).

FCC News Relating to Amateur Radio:-

-- Lower fee levels proposed for Vanity Calls: In a Notice of Proposed Rule Making released March 25 (MD Docket 98-36), the FCC proposes, among many other things, to change the fee for an amateur vanity call sign to \$1.29 per year for Fiscal Year 1998 (that is, \$12.90 for the ten-year term of the license instead of the current \$50). The details are in section 13 of Attachment H. Fiscal Year 1998 starts Oct. 1, 1998. It is also proposed that there will be no refund from the current fee amounts to the new level for current Fiscal Year 1997 applicants.

Comments are due April 22, 1998, and reply comments by May 4. Comments must be in hard copy format. No e-mail comments will be accepted.

-- Proposed new licensing procedure: On Mar. 20, the FCC released a Notice of Proposed Rule Making, Docket WT 98-20, "To Facilitate the Development and Use of the Universal Licensing System in the Wireless Telecommunications Services." Comments must be filed by May 7, 1998, with reply comments by May 22. Comments must be in hard copy format. No e-mail comments will be accepted.

The NPRM apparently proposes no changes in privileges or qualifications for any class of license. Key goals appear to be:

- 1. Replacement of the venerable Form 610;
- 2. Elimination of the Form 610-A, thus providing paperless reciprocal licenses;
 - 3. Proposed privatization of club licensing.
- 4. Require use of Taxpayer Identification Numbers (usually Social Security numbers).

-- Electronic filing of documents in rulemaking proceedings: In GC Docket 97-113 amended its rules to allow the public to file comments and other pleadings electronically via the Internet using the Electronic Comment Filing System (ECFS). The ECFS is currently available in proceedings specifically designated by the Commission, but will be available generally when the rules adopted on April 2 go into effect in "early June 1998". The Commission will issue a Public Notice indicating when the ECFS will officially be available for general use and how to use the new system.

ARRL Asks FCC To Support Voluntary Band Plans:-

On April 3, based on action taken at the January ARRL Board meeting, the League formally asked the FCC to issue a declaratory ruling to equate observance of voluntary band plans with "good amateur practice."

The League requests the Commission "at an early date" declare that good amateur practice "anticipates compliance with the accepted voluntary international, national, and regional band plans adopted by cooperation and coordination" within the Amateur Radio Service.

The League's filing builds on a 1983 declaration by the Chief of the FCC's Private Radio Bureau that simplex operation on a recognized repeater frequency was contrary to good amateur practice.

McGan Silver Antenna Award Nominations Open:-

Nominees are welcome for the seventh annual Philip J. McGan Memorial Silver Antenna Award, a chance to honor the ham who did the most to promote Amateur Radio in 1997. The McGan award was named for journalist Philip J. McGan, WA2MGQ (SK), the first chairman of the ARRL Public Relations Committee. It goes to the ARRL member who demonstrates volunteer public relations success on behalf of ham radio at the local, state or national level, and who best exemplifies the volunteer spirit of the award's namesake.

Public relations (as opposed to public service) activities are those specifically directed at bringing Amateur Radio to the public's attention in a positive light--typically through the media (newspapers, TV, radio).

Call for Applications for 1998 Scholarships:-

The Foundation for Amateur Radio, Inc., a non-profit organization with headquarters in Washington D. C., plans to administer sixty-six (66) scholarships for the academic year 1998-99 to assist licensed Radio Amateurs. The Foundation, composed of over seventy-five local area Amateur Radio Clubs, fully funds nine of these scholarships with the income from grants and its annual Hamfest. The remaining fifty-seven are administered by the Foundation without cost to the various donors.

Licensed Radio Amateurs may compete for these awards if they plan to pursue a full-time course of studies beyond high school and are enrolled in or have been accepted for enrollment at an accredited university, college or technical school. The awards range from \$500 to \$2500 with preference given in some cases to residents of specified geographical areas or the pursuit of certain study programs. Clubs are encouraged to announce these opportunities at their meetings, in their club newsletters, during training classes, on their nets and on their WWW pages.
