#### Why Aren't They Ignoring the Jammer???

You've heard it here before; when there is a jammer on the repeater, IGNORE him. If you have a strong enough signal to override the interference, continue with your QSO. If not, choose another repeater or make use of your OFF switch.

But that has not been happening lately on 523. Don't these people know any better? Yes, they do. Unlike a normal fox hunt where the fox transmits at regular intervals until found, a jammer frequently uses the hit-and-run technique. Even with the sophisticated equipment in use today for fox hunting, short, infrequent transmissions are hard to find.

Certain hams who are working with the fox hunters are intentionally not following the normal advice in order to keep the jammer transmitting long enough to take bearings.

Should you do the same? No, not unless specifically requested to assist by one of the fox hunters. If you have DF equipment and want to help locate and identify the jammer, contact Andy, VE3FZK, who can frequently be heard on 145.230 during the morning commute and on Monday evenings during the PAARA net which is at 8:30 P.M. on our repeater.

# **Jerry Bliss Bio**

Jerry Bliss has been part of SPARK and The Company for a very long time. If you would like to know a bit more about Jerry, check out the Bio he provided to NCDXC recently.

Jerry Bliss, K6III,

First licensed in 1953 at the tender age of 13 as KN4AHC (Novice), later moved to CA and became KN6JHO (Novice). Dad had a ham radio he had purchased from some ham in Canal Zone (KZ5), but he wasn't licensed. It was home brew and had all kinds of knobs and switches. I fooled around with the receiver (an HRO-7) and discovered the wide world of radio. Dad finally got his license (WB6LOS) about 1970 or so, after he retired.

My license lapsed after a year. In 1957 join the US Navy and was trained as a Radio Operator where I really learned my CW and technical radio stuff. While in USN, licensed as K6SMH (General). Did a bit of operating at club stations during my USN days (3 years). Most operating was Ship-to-Shore CW aboard Submarine (USS ROCK an old WW2 Diesel powered job) around San Diego and Pacific.

After 3 years active USN, joined USNR and went to San Jose City College for an Associate Degree in Electronic Technology. While working at Ford Aerospace, joined the SPARK club and served as Secretary and later President. There I upgraded to Extra class. During my USNR days, you would occasionally find me on from Hawaii (KH6SP) or Guam (KG6AA), both USN club stations, or even from a Navy P3 Orion airplane. I'm now retired from USNR having made it all the way up the ranks to Master Chief Radioman (Submarine Qualified, I hasten to add!).

I joined NCDXC some 20 years ago and just stayed in the background working DX, mostly on CW. Not far up the ladder, about 250 or so. Tried to work most of the expeditions, but mostly rag chew and lately contesting. Yes, I'm also a member of NCCC too (joined up this year at the joint NCDXC-NCCC meeting). Gotta couple of operating awards to wall paper the shack. The rig is a ICOM-751a plus the ICOM IC2-KL linear (400w) radiating from wires and a Force-12 C3 at 45 feet, all down in the flat lands of the Santa Clara Valley (a pretty competitive section). You'll find me on the TI-Repeater sometimes; usually in the background, but sometime quite outspoken and noisy. Also on the DX Packet cluster.

While working in England for several years (Software Engineering), I was active as GOCLY and did a lot of operating at the club station GOFOS (and a few other special event calls, GB5DX, GB75USA, GB4JUL). I worked a lot of NCDXCers with that call. I even held the special event call GB1ISS... with a little imagination, you can make the "1" into a lower case "L" and walla... you have my name! Also went back to University and collected my BS in Information Systems Management at night school.

A couple of years ago, I changed my call from K6SMH to K6III. I took a bit of flack on the TI-Repeater about that "III" business, but I gotta tell you, it really works busting the pile ups! Oh, the "III" bit is from the end of my name; I'm G. D. Bliss, III - I just couldn't resist ( lot of ego, here, you know!).

Well, in 1994, I retired from Ford Aerospace after 27 years. I laid low for a couple of years before I went back to work at Landis & Gyr in San Jose as a Quality Assurance Analyst. This job came through a chance ham radio contact.

As for the family, XYL Betty Ruth (we call her BR), 3 kids, 4 grandkids. Son is KE6WHD, Daughter is KE6TNX, Son-in-law is KQ6LQ. XYL, well she just tolerates all this ham radio jazz. But she has just discovered e-mail and the Internet! Since the PC also occupies the station, I have to schedule my time on when she isn't.

OK, thanks for entrusting me with the NCDXC Secretary job; I hope I do a creditable job; I'm sure I will get lotsa support from Venerable Goat.

# Amateur Radio Spectrum Protection Act Needs Cosponsors:-

On March 27, Representatives Michael Bilirakis (R-FL-9th) and Ron Klink (D-PA-4th) introduced HR 3572, the Amateur Radio Spectrum Protection Act of 1998.

The operational portion of the bill is Section 3 (see below), which, if passed, would require the FCC to provide "equivalent replacement spectrum" if the Commission reallocates any primary or secondary Amateur Radio frequencies.

Our strategy is very straightforward - obtain as many House cosponsors as we can before the end of the legislative session and elections later this year. To date we have the following cosponsors in the Pacific Division -- Patsy Mink (D-HI-2) and Tom Campbell (R-CA-15). Let's get more of the Pacific Division House Members to be cosponsors! Cosponsors don't vote against their own bills! Here is Section Three:

"SEC. 3. FEDERAL POLICY REGARDING REALLOCATION OF AMATEUR RADIO

SPECTRUM.

Section 303 of the Communications Act of 1934 is amended by adding at the end the following new subsection:

- (y) Notwithstanding subsection (c), after July 1, 1998--
- (1) make no reallocation of primary allocations of bands of frequencies of the amateur radio service;
- (2) not diminish the secondary allocations of bands of frequencies to the amateur radio service; and
- (3) make no additional allocations within such bands of frequencies that would substantially reduce the utility thereof to the amateur radio service; unless the Commission, at the same time, provides equivalent replacement spectrum to the amateur radio service."

Here is a draft sample letter to send to your Congressperson to enlist him/her as a cosponsor:

The Hon. (congressperson's name) Longworth House Office Building Washington, DC 20515

Dear Representative (congressperson's name):

As one of the nation's more than 650,000 licensed radio amateurs, I urge you to sign on as a cosponsor to HR 3572, the Amateur Radio Spectrum Protection Act of 1998.

This bill, introduced by Representatives Bilirakis and Klink on March 27, is a non-partisan, non-controversial measure designed to afford a measure of protection to Amateur Radio frequencies used by radio amateurs in (state name) and elsewhere to provide emergency communication, technical experimentation and recreation.

The bill would require the Federal Communications Commission to provide "equivalent replacement spectrum" in the event it becomes necessary to reallocate radio frequencies currently allocated to the Amateur Service.

This is a matter of fairness, and is in the national interest.

The bill would help ensure Amateur Radio's continued public service role to the people of the State of (state name).

Brief Summary of Some of the Many FCC News Items Relating to Amateur Radio:-

- Lower fee levels proposed for Vanity Calls: In a Notice of Proposed Rule Making released March 25 (MD Docket 98-36), the FCC proposes, among many other things, to change the fee for an amateur vanity call sign to \$1.29 per year for Fiscal Year 1998 (that is, \$12.90 for the ten-year term of the license instead of the current \$50). The details are in section 13 of Attachment H. Fiscal Year 1998 starts Oct. 1, 1998. It is also proposed that there will be no refund from the current fee amounts to the new level for current Fiscal Year 1997 applicants.

The deadlines for Comments and Reply Comments has passed.

- Proposed new licensing procedure: On Mar. 20, the FCC released a Notice of Proposed Rule Making, Docket WT 98-20, "To Facilitate the Development and Use of the Universal Licensing System in the Wireless Telecommunications Services." Comments were due by May 7, 1998; Reply Comments deadline has been extended to June 16, 1998. The NPRM apparently proposes no changes in privileges or qualifications for any class of license. Key goals appear to be:
  - 1. Replacement of the venerable Form 610;
  - Elimination of the Form 610-A, thus providing paperless reciprocal licenses;
  - 3. Proposed privatization of club licensing.
  - Require use of Taxpayer Identification Numbers (usually Social Security numbers).

- On April 3, the League asked the FCC to issue a declaratory ruling to equate observance of voluntary band plans with "good amateur practice." The League requested the Commission "at an early date" declare that good amateur practice "anticipates compliance with the accepted voluntary international, national, and regional band plans adopted by cooperation and coordination" within the Amateur Radio Service.

The League's filing builds on a 1983 declaration by the Chief of the FCC's Private Radio Bureau that simplex operation on a recognized repeater frequency was contrary to good amateur practice. All that was wanted was the current Commission to say that this declaratory ruling was still policy.

Unfortunately, contrary to the League's procedural request and without informing the League, the FCC made this request into a Rule Making process (something entirely different); this process itself apparently caused considerable confusion in the ham community as to just what was being requested. Also many used this matter to comment on unrelated issues.

Comments were due on May 21.

Because of what has happened to date, it is not clear what happens next.

- RM 9267, a Petition requesting access to the 70 CM Amateur Band and other non Amateur Radio spectrum was submitted by the Land Mobile Communications Council (LMCC), released for public comment by FCC on April 30, 1998.

The ARRL believes that the LMCC proposal is incompatible with continued amateur use of the band. RM-9267 is only a proposal. Many hams and others commented to FCC and to the groups making up the LMCC (including the American Automobile Association) opposing this petition. Several organizations in and outside the Federal Government have filed in opposition.

Detailed information on this Petition and Comments are available on the Pacific Division WWW site, pdarrl.org, and the ARRL www site, arrl.org. Many more details on RM 9267 were covered in Special Editions of the Pacific Division Update on May 8 and 12. The deadline for Comments on the Petition in hard copy format was June 1, 1998. Reply Comments deadline has apparently been extended to July 16, 1998, at the request of one of the LMCC members. No e-mail comments are permitted.

- The FCC has several items (undefined and unpublished so far) in process under the name of the "1998 Biennial Review." Congress mandated in the Communications Act a "review aimed at simplifying, eliminating or modifying regulations that are overly burdensome or no longer serve the public interest." This review is across all services including the Amateur Radio Service. At this writing it is not known what may be proposed or when.
